**Welcome to Bluejay Nation**

We are all here to accomplish the goals and objectives of the Bondurant-Farrar Community School District. To be Bondurant's BEST, reasonable standards of discipline and mutual respect are necessary among all students and school employees. This handbook is designed to assist students and parents/guardians in gaining an understanding of the basic operational procedures required of all RISE students. Students who attend the RISE Program fall under the guidance of this handbook as well as the Bondurant-Farrar High School Student Handbook. High School / Student Handbook.

**Please read the following to determine if the RISE Program is the right choice for you.**

- RISE is for students who have not been successful in the typical high school setting due to significant behavior challenges. RISE provides a comfortable, safe, and welcoming environment where the rights of others are respected.
- Students work at a pace that benefits their own learning style.
- Class size is smaller allowing for more individual attention.
  - RISE capacity is six students
- Students are expected to attend class and arrive on time.
- Parents are encouraged to attend Parent/Teacher Conferences.

**Criteria for Admittance:**

Students must be:

- A resident of Bondurant-Farrar
- In grades 9th-12th
- Referred by an IEP team or MTSS team and approved by the Bluejay RISE committee
  - Included in the referral form must be a description(s) of previous supports/plans
  - Students may have an IEP with a BIP, but not required

**Schedule:**

- Monday school will start at 9:00 and dismiss at 1:00
- Tuesday - Friday school will start at 9:00 and dismiss at 2:30
- Lunch will be delivered beginning at 11:00 am daily
- Snow delay schedule
  - Late Start 10:00 am
  - Early Dismissal 1:00 pm

**Attendance:** *If a student is absent a parent or guardian must report their child absent to the High School office. The High School office will then notify the RISE teacher.*

The RISE program's start time is 9:00 each day. Any student who is later than 9:15 will be considered tardy unless following an individualized attendance contract. Individualized attendance contracts must be approved by the program director.

- Students will start the RISE program following the standard RISE schedule (i.e. 5 days a week, full days), unless otherwise noted in their IEP.
- Any changes to the schedule that results in less instructional time (i.e. fewer days, shorter days), needs to be determined by the IEP team during an IEP meeting.

- Any changes to the schedule that does not impact instructional time (i.e. arrive early and/or stay late) can be made by the teacher, parents, and student.

In the event a student in the RISE program is not attending, a meeting will be held (i.e. IEP meeting) to determine barriers to attendance. After three meetings with the family, if the student is still not attending they may be dropped from the program.

### **Continuation of Eligibility:**

Continuation of eligibility will be reviewed annually. Students will remain eligible and enrolled in the RISE program as long as they are making appropriate progress. Appropriate progress will be determined by the RISE committee with input from the IEP and/or MTSS team. If a student is no longer eligible for RISE they will return to the traditional high school setting, unless a different placement is determined appropriate by the IEP team.

### **Credit Requirements:**

Students in the RISE program will be required to earn 48 credits in order to graduate high school. A reduction of required credits (i.e. 40 credits) will be determined on an individual basis and documented in the student's IEP if appropriate. The determination to make a class pass or fail will be made on a case by case basis by the IEP team.

### **Program Curriculum:**

- Students will access curriculum either through Google Classroom or Edmentum.

Google Classroom Courses: Courses offered through Google Classroom will align with the courses of the same name/content at the traditional high school. These courses may differ in terms of specific assignments but will utilize the essential outcomes developed by each High School content specific department based on the Iowa Core. Although format may be different, students need to demonstrate learning through assessments.

Edmentum Courses: Edmentum courses will be reduced to tutorials and mastery tests. No additional assignments will need to be completed. Students will be required to complete the tutorial before taking mastery tests. Mastery tests will be reset up to three times. If a student does not pass (60%+) a mastery test after three attempts, they will need to review the tutorial with an adult before the test will be reset again. Students are not allowed to have internet searches open while working on Edmentum courses.

Students may choose to complete an Edmentum PE course or complete and record physical activity/steps on a spreadsheet in order to earn PE credits.

- If choosing to complete the Edmentum course, students must complete the entire course with a passing grade.
- If choosing to complete physical activity, 1000 minutes of activity is needed to earn .5 credits. Spreadsheets must be updated

weekly and physical activity may include working out at the gym, participating in a recreational game, swimming, or riding a bike. Additionally, students may choose to submit steps obtained from walking or running. In this case, 4000 steps would be equivalent to 30 minutes of activity. Students cannot record more than 1 hour of physical activity per day but can include weekend activity time.

- Students will receive direct, small group instruction based on needs outlined in each student's individual plan.
- Students are eligible to enroll in classes at the High School without permission from the RISE committee. However, if appropriate progress is not being made or if the student cannot meet behavior expectations, the student will be dropped from the class.
- Students will have group counseling once a week provided by a school counselor.
- Students will have the opportunity to meet individually with a mental health counselor on a weekly basis.

### **Extracurricular Events**

RISE students may participate in extracurricular activities. These activities include school dances, athletic events, homecoming festivities, and clubs and athletic teams. To participate, the student must be a student in good standing and meet the academic and good conduct eligibility requirements, per the Bondurant Farrar High School Student Handbook, the RISE Student Handbook, and the Iowa High School Athletic Associations requirements.

### **Student in Good Standing:**

To be considered a student in good standing, students must meet the following criteria:

- Academically eligible
- No outstanding detention
- No outstanding fees/fines

The inability to meet the above criteria, will impact students in regards to their participation in school sponsored activities, which will be determined by the RISE committee.

### **General Information:**

**Computer Usage:** All students will have access to a district computer. Student computers will be used as needed and will stay on site.

**Food Rules:** Approved activities for bringing food to a classroom for an approved activity is permitted, under the following guidelines and recommendations as per the Healthy Kids Act: All snacks sent to school for the consumption of others must be pre-packaged. In an effort to support the Healthy Kids Act, we encourage parents/guardians to provide healthy alternatives for classroom celebrations. Information about the Healthy Kids Act can be found on the Iowa Department of Education website.

**Leaving School during the School Day:** Students leaving school before the normal dismissal time must have the program director or high school principal's permission. If parents/guardians want an early dismissal for their son/daughter, they must call or must sign a written request stating the reason. Students who have been authorized to leave early are to check out prior to leaving the building. Unauthorized leaving will constitute truancy. Any student who leaves the RISE campus without permission from the RISE teacher or Director of Special Education may be disciplined.

**Lunch:** Students are allowed to leave for lunch if they return within the appropriate time frame. If a student is late returning to school following lunch, they will lose open lunch privileges for 2 weeks. No student is to leave the RISE campus without permission from the program director or HS principal. Any student who leaves the RISE campus without permission from a school official will be disciplined.

**Discipline:** Specific behaviors of concern will be defined in each individual students' plan and when assigning consequences plans will be followed. Other discipline and consequences will follow the BFHS handbook.

**Smoking, Tobacco and Vaping Possession Policy:** Students in possession of tobacco, smoking or Vaping on school grounds will be referred to the School Resource Officer and the High School Administration. Students may be issued a police citation for drugs and/or alcohol in lieu of a suspension.

**Sexual Harassment:** Sexual harassment is any sexual behavior that is unwanted or unwelcome. Sexual harassment will not be tolerated in the RISE Program. Sexual Harassment includes offensive language, offensive gestures, and unwanted sexual advances. Students are asked to report such incidents to the instructor or the High School Administration.

**Emergency/Physical Removal:** The purpose of this policy is to give permission and authority to the school administrators to physically remove a student from a classroom, school facilities, or grounds when it has been deemed necessary in handling disciplinary matters. In the event a student becomes belligerent, the school administrators may incorporate the help of other school personnel in order to remove the student. In some cases, it may be necessary to have law enforcement authorities become involved in the situation.

**Bus Safety/Transportation:** Students who have specialized transportation will be dropped off at the front of the RISE building. Students who participate in classes at both the alternative building and the high school will be provided transportation by the school.

**Fire:** In the event of a fire, students and staff in the RISE classroom will exit the building through the safest, fastest, and most clear route of egress (i.e. front or back) door. Emergency signs will be posted in the classroom. Occupants will cross the street on the east side of the building and stand in the public parking lot until approval to reenter the building is granted by the fire department or administration.

**Severe Weather:** In the event of severe weather, students and staff will take cover in the main hallway and/or restrooms.

**Program Telephones:** The primary telephone is a business phone and should be used by students for emergencies only. Parents should not call to talk to students, except in cases of a real emergency. Tardies to class or absences from class because students are using the telephones are unexcused unless a pass is received from the program director. Phones are answered between 8:00 A.M. and 3:00 P.M. The phone number is 957-8191. The bus garage is 967-2891 and the central office is 967-7819.

**Dress Code:** Students are to wear appropriate dress, which reflects good taste and is not disruptive to the educational environment. While students have a great deal of freedom and responsibility in school dress, some guidelines are to be followed. Footwear is to be worn at all times. While most clothing styles are acceptable, examples of unacceptable attire are midriffs, halter-tops, unfinished or inappropriate tank tops and shorts or skirts that are too short. Additionally, clothing that displays obscene materials or profanity or advertise products that are in conflict with the policies and rules of Bondurant-Farrar High School Student Handbook, such as alcoholic beverages, drugs, tobacco, ETC. are considered inappropriate.

**Visitors:** Students are NOT allowed to bring visitors to the school. Visitors disrupt the educational environment. If an outside therapist, JCO, or other

support staff/adult needs to visit with a student, they will need to present a valid ID. These meetings will take place in the conference room, not in the classroom with other students.

**Care of Building and Equipment:** All students are responsible for leaving the program property and equipment in the same condition as when such facilities were made available to them, except for reasonable wear with proper use. Students will be held responsible for any damage to program properties; fines or cost of repair will be assessed when necessary.

**Level I Investigator:**

Procedures for investigations of abuse by employees are handled by the district Level I Investigators, Dr. Rich Powers, Chad Carlson, or Jodi Brogan who can be contacted by calling the district office at 515-967-7819.

**Section 504 Policy Statement:**

It is the policy of the Bondurant-Farrar Board of Education to provide a free and appropriate public education to each disabled student within its jurisdiction, regardless of the nature or severity of the disability. It is the intent of the district to ensure that students who are disabled within the definition of Section 504 of the Rehabilitation Act of 1973 are identified, evaluated, and provided with appropriate educational services. Students may be disabled under this policy even though they do not require services pursuant to the Individuals with Disabilities Education Act (IDEA). Due process rights of disabled students and their parents under Section 504 will be enforced. The Director of Instructional Services is the coordinator of Section 504 activities.
